Regulation (EU) 2016/679 (hereinafter referred to as **GDPR**) sets forth the rules for processing personal data and the free movement of such data.

Why we process your personal data

We will process your data based on the principles of fairness, lawfulness and transparency. We will keep them confidential, protecting your rights in compliance with the company's privacy policy. How we process your data

We collect the data you provide to achieve the above purposes.

Who we may share your data with

We may communicate your data to the following recipients or categories of recipients for the above purposes:

a) Consulting companies.

Moreover, we inform you that:

• communicating your data to the categories of recipients referred to in section a) is necessary to execute the contract you entered into.

In relation to these categories of recipients, the Data Controller undertakes to entrust only recipients who ensure data protection and will appoint them as Data Processors, in compliance with Article 28 of the GDPR. The list of data processors is available for your viewing. You can request a copy from the Data Controller.

Moreover, pursuant to Article 29 of the GDPR, employees and/or collaborators authorised and trained by the Controller will process your data exclusively for the above-mentioned purposes. Your data will not be disseminated unless forced to by law.

Your rights as the data subject

You can exercise your rights set forth in Articles 15-22 of the GDPR at any time. In particular, you have the right to request:
